## **Project study topic**

**Context:** Policymaking is still mainly driven by siloed thinking. The European Green Deal calls for a more systemic policymaking. However, even the implementation measures of the European Green Deal show that this decade long way of approaching and tackling problems does not vanish overnight. As the motivation is there and goals have been set – it is not clear which obstacles hinder the European Commission to apply systemic thinking. The same applies to other European Institutions and the EU's Member States.

**The Challenge:** Identify the key barriers to systemic policymaking in European Institutions and Member States. You will map the key transition obstacles (persons and underlying motivations) to implementing the Circular Economy on a political level. These might by vested investor interests, technical barriers or budgetary challenges. We support in providing exiting interview partners that have been steering leaders' narratives on climate behind the scenes for years, such as the "Global Strategic Climate Communications" group, a long-term partner.

We will outline the exact scope of this project together and challenge, as well as iterate it, during the project phase.
